Archibald Harper first born son to John Harper and Miriam Thompson his wife was born in Cherry Valley June 14th 1764 and was baptised by the Revd Samuel Sunlap
Died the 25 Sept 1825

Margaret Harper was born to do. the 8th of January 1766 and baptised by do

James Harper was born to do. October 15th 1767 and baptised by do.

Died the 16 Sept. 1828

Mary Ann was born to do at East Windsor April the 21st 1769 and baptised by the Revd Thomas Osborne Minister of the north East parish - Died May 3rd 1830

Abigail Harper was born to do the 10th of February 1771 - and departed this life March 30th 1779

Rebecca Harper was born to do January the 8th 1773 - Died July 26th 1826

John Harper was born to do at Harpersfield July 10th 1774

Ruth Harper was born to do at Harpersfield Sept. 21st 1776

Miriam Thompson wife to John Harper departed this life at the Mohawk River on the 25th of Sept. 1778

John Harper Son to James Harper and Jennet Luis was
born in Ireland in the county of Derry and Parrish of
Newtownlimadwy the 10th day of August 1705
Came to America in October 1720 with his Father
and Mother who had at that time five children viz.
three sons and two Daughters Anna the Eldest married to
James Miller in Ireland Joseph the Eldest son Married
to Aaron Thompson in Milton in Boston - William
Second Son Died unmarried - Sarah Second Daughter
Married to John Montgomery in Hopkinton near
Boston - the third son landed at Casco Bay in New
England and settled there but the Indians making
War two or three years after their arrival the
whole Family except John Moved to Boston
Survived Near four years against the Indians
afterwards came to Boston also was married by
the Rev. Saml. Barrett the 8th of Nov. 1728 to
Abigail Montgomery Daughter to W^m Montgomery
and Mary Aken (in Hopkinton) from Shillallo in
the county of Mayo in Ireland and settled at
Casco Bay in the year 1719 and was driven off
by the Indians war as above and settled in Hopkinton
in New England where John and Abigail were Married
W^m Harper their Eldest Son was born in Saddle Island
at Boston in New England 14th Sept. 1729 and
Received in the Town Clerks Office was Baptized
by the Rev. Mr. Clark James Harper Second Son
was Born in Boston the 26th of March 1731
Recorded as above Baptized by Mr. Morehead

Mary Harper was born in Boston 23rd June 1733 Baptised
by Rev. Mr. Moorhead. John Harper 3rd Son was born in
Boston 31st of May 1734 Baptised by Mr. Moorhead
Margaret Harper Born in Boston Died in 2nd year
of her age. Margaret Harper 2^d Was born in Boston
the 7th February 1740 was Baptised by Rev. Mr. Moorhead
Joseph Harper 4th Son was born in Middletown
in Connecticut the 11th of Feb. 1743 Recorded
in the town clerks office and Baptised by the
Rev. Mr. Russell

Alexander Harper 5th son was born in Middletown
22nd February 1744 Recorded in town clerks office
and Baptised by Rev. Mr. Russell

Abigail Harper was born in Middletown July 28
1745 Recorded in the town clerks office and
Baptised by Rev. Mr. Russell

Miriam Harper was born in ~~Windsor~~ in
Connecticut the 14th of February 1749 Baptised
by Mr. Edwards

John Harper removed from Windsor in Connecticut
to Cherry Valley in Albany county State New York
with all his family in October 1754

James Harper 2^d Son to John and Abigail Harper
departed this life by the Small pox 22nd
March 1760 in the 29 year of his age Interred
in the burying ground in Cherry Valley

Abigail wife of John Harper Mother of this family departed
this life at his house at the Beave dam in Cherry Valley
the 28th December 1767 in the 59th year of his age by
the consumption and interred by her second son James
by his right side in the burying ground in Cherry
Valley

John Harper Father of this Family Departed
this life the 20th of April 1785 at Harpersfield
being aged 79 years Eight Months and 10 days
and was buried by his children at Harpersfield

John Harper was married to Issabell Mus Knight
widow to Joseph Harper June at East Windsor
Dec. 26th 1784

Abigail Harper was born to said John and Issabel
Sept 8th 1785 and was baptised by the Rev.
Mr Group
